NOTICE OF ACCEPTANCE: SPECIFIC CONDITIONS

1. SCOPE

1.1 This renews the Notice of Acceptance No. 98-0421.01, which was issued on 07/30/98. It approves Eco-Block, Insulated Concrete Form described in Section 2 of this Notice of Acceptance designed to comply with the South Florida Building Code, 1994 Edition for Miami-Dade County (SFBC) and the specifications for rigid cellular polystyrene thermal insulation ASTM C-578.

2. PRODUCT DESCRIPTION

2.1 The Eco-Block, Insulated Concrete Form shall be fabricated in strict compliance with the following document: Drawing No. 98136, titled "Eco-Block 2000", Sheet 1 of 1, dated 06/18/98 signed and sealed by Alan J. Davis PE. It bears the Miami Dade County Product Control approval stamp with the Notice of Acceptance number and approval date by the Miami-Dade County Product Control Division. These documents shall herein after be referred to as the approved drawings.

3. LIMITATIONS

3.1 This insulation system may be used within fire rated assemblies that have been tested in accordance with ASTM E-119 or if protected by an approved automatic fire extinguishing system

4. INSTALLATION

4.1 This insulation system shall be installed in strict compliance with the approved drawing.

5. LABELING

5.1 Each block shall bear a permanent label with the manufacturer's name or logo, city, state and the following statement "Dade County Product Control Approved".

6. BUILDING PERMIT REQUIREMENTS

- 6.1 Application for Building Permit shall be accompanied by copies of the following:
 - 6.1.1 This Notice of Acceptance
 - 6.1.2 Duplicate copies of the approved drawings, as identified in Section 2 of this Notice of Acceptance




NOTICE OF ACCEPTANCE STANDARD CONDITIONS

- 1. Renewal of this Acceptance (approval) shall be considered after a renewal application has been filed and the original submitted documentation, including test supporting data, engineering documents, are no older than eight (8) years.
- 2. Any and all approved products shall be permanently labeled with the manufacturer's name, city, state, and the following statement: "Miami-Dade County Product Control Approved", or as specifically stated in the specific conditions of this Acceptance.
- 3. Renewals of Acceptance will not be considered if:
- a) There has been a change in the South Florida Building Code affecting the evaluation of this product and the product is not in compliance with the code changes;
- b) The product is no longer the same product (identical) as the one originally approved;
- c) If the Acceptance holder has not complied with all the requirements of this acceptance, including the correct installation of the product;
- d) The engineer who originally prepared, signed and sealed the required documentation initially submitted is no longer practicing the engineering profession.
- 4. Any revision or change in the materials, use, and/or manufacture of the product or process shall automatically be cause for termination of this Acceptance, unless prior written approval has been requested (through the filing of a revision application with appropriate fee) and granted by this office.
- 5. Any of the following shall also be grounds for removal of this Acceptance:
- a) Unsatisfactory performance of this product or process.
- b) Misuse of this Acceptance as an endorsement of any product, for sales, advertising or any other purpose.
- 6. The Notice of Acceptance number preceded by the words Miami-Dade County, Florida, and followed by the expiration date may be displayed in advertising literature. If any portion of the Notice of Acceptance is displayed, then it shall be done in its entirety.
- 7. A copy of this Acceptance as well as approved drawings and other documents, where it applies, shall be provided to the user by the manufacturer or its distributors and shall be available for inspection at the job site at all time. The engineer need not reseal the copies.
- 8. Failure to comply with any section of this Acceptance shall be cause for termination and removal of Acceptance.
